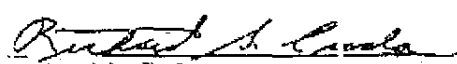

Pursuant to §607.1402 and §607.1403, Florida Statutes this corporation submits the following *Articles of Dissolution*:

- FIRST:** The name of the corporation is BAYVUE INC. OF FLORIDA, a Florida corporation (Document No. 305195) (the "Corporation").
- SECOND:** The Certificate of Incorporation of the Corporation was filed on May 18, 1966, and an Amendment of Certificate of Incorporation was filed on June 23, 1967.
