ARTICLES OF ORGANIZATION \mathbf{OF} 2301 MIAMI, LLC

SECTION 1 INTRODUCTION AND PRELIMINARY STATEMENTS

The undersigned organizer (Organizer) desires to form a limited liability company under the laws of the State of Florida by delivering these Articles of Organization in duplicate to the Secretary of State of the State of Florida, in accordance with Florida Limited Liability Company Act (Act).

SECTION 2 NAME

The name of the limited liability company is 2301 MIAMI, LLC, a Florida limited liability company (Company). AUG BUS

SECTION 3 **DURATION**

The Company will perpetually exist from the filing date of these Articles of Organization with the Secretary of State of Florida, unless dissolved according to law.

COMPANY'S PURPOSE SECTION 4
