

## ARTICLES OF INCORPORATION OF

LA DAMA ENTERPRISES, INCORPORATER LLAHASSEE, FLORIDA

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

#### ARTICLE I

The name of the Corporation ("Corporation") shall be LA DAMA ENTERPRISES, INCORPORATED.

#### ARTICLE II

The principal place of business and mailing address of the Corporation is 407 Lincoln Road, Suite 701, Miami Beach, FL 33139.

#### ARTICLE III

The existence of the Corporation shall begin on MAY 31, 1999

#### ARTICLE IV
